

## **Zahra Bahari or Marita Bahari (Undercover Con-Artist)**

Hojat Asgharnia has not worked since Ahmad Bahari died in 1990 and he sold his shop at the same time in order to cheat Ahmad Bahari inheritance property with Nasrin Taskini and Zahra Bahari.

They stole two properties and sold them to Faridoon Samavati and Aghdas Taskini illegally at very low price in 1992. One of the properties was sold by Samavati family for 3.8 million US dollar few years ago to the Bank Pasargard.

When our sister died in the airplane crash, I sent \$2000 to Nasrin Taskini and Mozafar Samavati took \$1000 from the money broker without my permission. I did not know until your mom told me when I visited Persia for the first time.

They tried to sell the shop in 2000 illegally but they failed and Ahmad Bahari son visited Rasht after twenty- seven years living in the USA and the war started.

When I visited Guilan for the first time, she was screaming at me that she needs her share of inheritance. I asked her where is Ahmad Bahari will and she left the house. She left a message on the TV that she will meet me the next day. She brought her uncle (Mohammad Shafi Taskini) to

talk me. Her uncle started scaring me that she will hurt me and make life very difficult for me in Persia if I stay in Guilan and I bother Nasrin Taskini and etc. Zarah Bahari was sitting close to the uncle and did not say one word.

In 2003, when I was sick and I asked Hossien Yazdanpenah to visit me and he called my sister and she told him that I can die and go to hell.

During my next visit when I took care of her inheritance and I tried to pay her tax when I called her to come to tax department to sign the documents she told me that she will go to the police department and tell them I came from the USA and bothering them.

They tried to sell a house in 2013 illegally again. The first buyer was Hojat Asgharnia relative who owns a public bath business (Melat) and they failed because the son living in the USA has 50% of the share and the title and his name was in the Title Department computer database. They told the court that I was lost in the USA again and used a rental apartment as my address and never told me that they were selling the house.

She took me to an attorney office (Hojat Asgharnia friend) and he was explaining to me that she and her mother could sell the house without doing the inheritance process. I told him please go back to school and study your subject again. He told me if I knew the law why I came to visit him. I left his office right away. The attorney did not know I have been studying the Persian inheritance law since I visited it for the first time. Later on he told to her that he made a mistake and he asked her how I know the laws.

Zahra Bahari does not live with her husband anymore and using her graduate school as an excuse to live in her father house. We will see where she will live when she does not go to the school in the summer.

She is bipolar and she is not taking her medicine anymore and she is teacher and is a risk to her student at work and student at University of Lahijan.

Their son is 31+ years old and he has never worked in his life. He learned how to be lazy from his father (Hojat Asgharnia), grandmother (Nasrin Taskini) and Samavati families.

She got \$2000 from me a long time ago and its current value must at least \$3000. She decided to pay me monthly in 2014. She makes \$320 per month as a teacher and almost half of her salary will be given to her husband (Hojat Asgharnia) who is a free loader and is like Mozafar Samavati. She has to work three years without spending a penny to cover that money to me.

She is mad because I caught her lies and cheating on my inheritance share of properties by telling why I did not call her when father and the sister died. I sent money both times after calling your mom not you. She was getting my death certificate in Persia and getting my power attorney through Sholeh Samavati, Mozafar Samavati, and Farah Samavati in Houston the same time.

You helped me by sending the copy of birth certificate from Persia 11 years ago in order to get my passport but I did not know why you help me until I met you in Rasht. You wanted me to give my share of inheritance to you and Nasrin Taskini. When I did not want to do it the war started.

The day after being attacked by the Samavati family she was talking to Amir-Reza Samavati. When I tried to get the phone from her, she closed the door and I hurt my hand by pushing the door and I made a hole on the door. She was crying for the door for three hours and she told Nasrin Taskini to call the police so I will go to the jail and I will never come back to the USA. **These people know how to call police for me but not for Samavati when they attack on me and our property.** After crying three hours for the door, she started crying that she likes me and she will die for me. She turned the DSL modem off so I cannot contact my wife in the USA. (Homa Yazdanpanah was witness because I was talking to her over the phone). She is bipolar and needs to go to the doctor. She has been confused because of a mother and a husband con-artists and crooks.

When I asked her who the buyers of the house were and where is the office of con-artist attorneys? I have never got any correct answers from her and her mother. I found out everything by myself and when I asked her go to the court and close the auctioning the house case, she went to the court and cancel the attorney but did not close the case. She told me that she closed the case and I asked her where is the closing documents? She said we do not get the document we get a number. I went to the court and I found out that she did not close the case and I took Nasrin Taskini with me to the court and she called her. She came from the school and we closed the case. Her husband was very mad at her later on at night when they were talking over the phone why she closed the case of selling the house.

After the incident, she divided the house so I cannot use their area. That is fine with me. I will have my room that I grew up and I will have the second room and use the outside shower and bathroom. She needs to get rid of the renter and clean the second room from all those junkies. These people do not follow the laws and are illogical, they tried to sell the house illegally with the con-artist attorneys without my permission and they divided the house without the laws.

All members of Taskini, Samavati, Bahari, and Asgharnia are bad and corrupted and I do not have anything to do with them except fighting for my legal rights and Ahmad Bahari will implementation.
